

# Contest Rules

## The Colibri Center for Human Rights “Migrar Es Amar” Giveaway!

Contest ends on August 16, 2020 at 11:59pm PT. Winners will be selected in a random drawing on August 17, 2020. Winners will be announced by August 17, 2020 at 12:00pm PT on Facebook and Instagram and messaged via email.

### OFFICIAL RULES

1. NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. SUBJECT TO FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS. VOID WHERE PROHIBITED.

2. Eligibility. Subject to the additional restrictions below, The Colibri Center for Human Rights “Migrar Es Amar” Giveaway is open to everyone within the U.S.

3. How To Enter: The “Migrar Es Amar” Giveaway will begin at 1:00 pm, PT on Saturday, August 8, 2020 and end at 11:59 pm, PT on Sunday, August 16, 2020 (the “Giveaway period”). To be eligible all entries must be received before 11:59 pm PT on Sunday, August 16, 2020. Maximum of one winner per prize per social media platform (Facebook and Instagram). Sponsor will not be responsible for incomplete, lost, late, or illegible entries or for failure to receive entries due to transmission or technical failures of any kind, including, without limitation, malfunctioning of any network. All entries become property of Sponsor and none will be returned. Any questions regarding the number of entries submitted shall be determined by Sponsor in its sole discretion, and Sponsor reserves the right to disqualify any entries by persons determined to be tampering with or abusing any aspect of the Giveaway.

Winners have 24 hours to respond to our outreach before forfeiting the prize and a selection of a substitute winner from among all remaining eligible entries. To claim prize, the winner must provide a valid mailing address within the U.S. Winners may waive their right to receive prizes. Prizes are non-assignable and non-transferable. No substitutions allowed by winner. Prizes and individual components of prize packages are subject to availability and Sponsor reserves the right to substitute prizes of equal or greater value.
